UNA ORDENANZA DEL CONSEJO MUNICIPAL DE LA CIUDAD DE MISSOURI CITY, TEXAS, QUE SOMETE A ESCRUTINIO LOS RESULTADOS DE LAS ELECCIONES ESPECIALES DEL 1 DE MAYO DE 2021, CON EL FIN DE SOMETER A LOS VOTANTES CALIFICADOS DE LA CIUDAD CIERTAS MEDIDAS RELACIONADAS CON ENMIENDAS A LOS ESTATUTOS DE LA CIUDAD EXISTENTES; QUE DECLARA LA ADOPCIÓN DE CIERTAS ENMIENDAS PROPUESTAS A LOS ESTATUTOS; Y QUE DISPONE SEPARABILIDAD.

CONSIDERANDO QUE, el 1 de febrero de 2021, el Concejo Municipal de la Ciudad de Missouri City, Texas (el "Concejo Municipal") convocó debidamente a unas elecciones especiales a celebrarse el 1 de mayo de 2021; y

Sección 1. Que, por medio de la presente, los hechos y declaraciones establecidos en el preámbulo de esta Ordenanza se declaran verdaderos y correctos.

Sección 2. Que, por medio de la presente, se declaran los resultados de dichas elecciones especiales de la Ciudad y se incluyen en el presente documento, así como la aprobación de las propuestas estatutarias A, B, E, F, G, H e I. Dichas propuestas pasarán a formar parte de los Estatutos de la Ciudad de Missouri City, Texas, y por la presente se declara que se adoptan las propuestas A, B, C, D, E, F, G, H e I que enmiendan los Estatutos, tal como se establece en la Ordenanza N.º O-21-04, adoptada el 1 de febrero de 2021, que convoca a dichas elecciones especiales.

Sección 3. Por medio de la presente, el alcalde queda autorizado y se le instruye que certifique ante la Secretaría de Estado de Texas una copia autenticada de las enmiendas estatutarias bajo el sello de la Ciudad que muestre la aprobación de los votantes calificados de la Ciudad.

Sección 4. Los resultados oficiales serán entregados a la secretaria municipal, a quien por medio de la presente se le instruye ingresar en el registro electoral las tabulaciones de los votos emitidos para cada medida con el fin de preservar tales tabulaciones, según lo exigido por la ley.

Sección 5. Que se otorgó la notificación de dichas elecciones de manera debida y adecuada, según lo exigido por la ley, que dichas elecciones se celebraron como corresponde y que los resultados de las mismas fueron presentados por los funcionarios competentes para dichas elecciones y en todo de conformidad con la ley.

Sección 6. *Separabilidad.* Que si alguna sección, subsección, oración, cláusula o frase de esta Ordenanza, o su aplicación a una persona en particular o a un conjunto particular de circunstancias, llegara a ser considerada inválida por cualquier motivo, dicha invalidez no afectará de ninguna manera las partes restantes de esta Ordenanza y, para tal fin, las diversas partes y disposiciones de esta Ordenanza se declaran separables.
