- (b) **Texas Government Code, Section 551.087** - Deliberations regarding commercial or financial information that the governmental body received from a business prospect that the governmental body seeks to locate, stay, or expand in or near the territory of the governmental body and with which the governmental body is conducting economic development negotiations: (i) mixed use developments; and (ii) commercial development project.
