CANDIDATE ELIGIBILITY REQUIREMENTS AND DEADLINE TO FILE	
CANDIDATE ELIGIBILITY REQUIREMENTS	DEADLINE TO FILE CANDIDATE APPLICATION
1. MUST be a United States Citizen. 2. MUST be at least 18 years of age or older on the commencement of the term filled at the election. 3. MUST be a registered voter of the City of Missouri City as of the filing deadline. 4. MUST have resided continuously in Texas for twelve (12) months and the City for 6 months immediately preceding filing deadline. 5. MUST NOT have been finally convicted of a felony (unless pardoned or otherwise released from the resulting disabilities). 6.
